STREET TREE WORK PERMIT REQUIREMENTS

Requirements for having a contractor perform maintenance on a street tree are as follows:

- A certified ISA (International Society of Arboriculture) Arborist must perform the work; a listing of local certified arborists by zip code is available at: treesaregood.com
- Contractor must carry and submit proof of Workers' Compensation insurance, Property Damage insurance and Liability insurance in the amount of \$1 million dollars or more;
- Contractor must have a State of California Contractors License to do tree work. Acceptable licenses include the following: D-49 or a C27 Landscape license;
- Contractors applying any type of spray or soil injection to a street tree must have a Qualified Applicators Certificate (QAC) from the California Department of Pesticide Regulation;
- Contractor must meet with the City Arborist on site the day work is to be done. Please give at least 72 hours' notice prior to work being performed;
- Permit application must have the signature of the applicant;
- Homeowner must provide proof of liability and property damage insurance.
- The City Arborist makes the final decision on all street tree removal requests.

*** Permit can take up to 14 business days for preparation once all the documentation needed is received by the City. Please plan ahead.**
